

## EXPRESSION OF INTEREST FOR PROVISION OF COMMISSIONING SUPPORT VESSEL SERVICES

**Eni Rovuma Basin B.V., Mozambique Branch – Offshore Delegated Operator**, acting for and on behalf of **Mozambique Rovuma Venture, Area 4 Operator**, invites interested companies to submit *Expression of Interest* for the provision of Commissioning Support Vessel services in support of subsea commissioning and start up activities. The activities are to be performed in Area 4 of Rovuma Basin, at approximately 135 nautical miles offshore from the north east coast of Pemba, Mozambique.

### SCOPE OF WORK

The scope of work consists of provision of commissioning & startup support services for subsea production facilities by means of Light Construction Vessel (LCV) or Inspection Maintenance & Repair (IMR) vessel and possibility to use the vessel as accommodation vessel for client personnel.

The Vessel shall operate in a water depth range of 2,500 m and shall comply with the following minimum requirements:

- ✓ Crane capable of installation / retrieval tasks of subsea equipment with a weight of about 20 metric tons;
- ✓ Nr. 2 work-class ROV systems for subsea support activities up 3000m WD;
- ✓ 400 m<sup>2</sup> of Deck space;
- ✓ Minimum available accommodation of up to fifty (50) POB for Client personnel on top of Marine and ROV crew;
- ✓ Dynamic Positioning Class DP2.

Services will be required indicatively starting from first half of 2022 for a period of up to five (5) months.

### DOCUMENTATION REQUIRED

Companies interested in this invitation may submit their *Expression of Interest* by providing through the below specified link, the following mandatory information and documentation:

#### I. Technical Documents:

- a) Filled Qualification Form of the Requirements for the Technical Pre-Qualification of Offshore Vessels Owners;
- b) Document of Compliance (DOC) issued under SOLAS 74/78 Chapt.IX, Reg.4 for the type of vessel to be managed; in case DOC is not in the name of the entity wishing to participate to the Expression of Interest, evidence shall be provided of the relationship between such entity and the DOC owner;
- c) HSE Management System Manual or list of documents evidencing alignment with international standards (e.g. ISO 14001; BS 18001 or ISO 45001) and/or evidence of a certified HSE Management System.
- d) Any other information that will establish that your Company is capable of fulfilling the scope of work.

#### II. Administrative Documents:

- a) Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification and other relevant information from Eni Rovuma Basin B.V.;
- b) Last three years of Financial Statements and Annual Reports including Balance Sheet, Profit and Loss and Cash Flow Statement proving minimum financial capability to carry out the scope. These documents must be provided for the Company Group (if applicable), and also for the Company's entity that will potentially enter into the subject contract;
- c) Company's registration in Mozambique. In case your Company is not already registered in Mozambique, please specify if you would be willing to promptly register in Mozambique and spec-

ify the respective timeline;

- d) Company and Group structure with the list of major Shareholders and ultimate beneficiaries (if not listed in the stock exchange);
- e) In case you wish to participate in the Expression of Interest as a consortium or as a joint venture, information about each member of consortium or joint venture and role of each participant in the potential project. Such intention to form either a consortium or a JV, must be supported by an Agreement or "Memorandum of Understanding" duly signed by each entity in the group;
