### **SCOPE OF WORK**

ROV services shall be necessary to support Coral South operation phase.

ROV system shall be compatible to be installed/uninstalled on call basis onboard Company vessel with the following equipment and personnel:

- Class 3 heavy duty WROV
- Rated for 2500 m water depth
- 200m ROV range
- Minimum power 250 HP
- 5 & 7 function manipulators (scope of work will be provided in tender)
- Camera with at least 6 channels of which 2 in HD and 4 standard, for visual inspection and footage
- Support for torque tools in compliance with ISO 13628-8-Class 6
- Dedicated HPU
- LARS
- Control rooms and workshop containers
- ROV operator/s

Companies are requested to provide an optimized ROV layout that could minimize space onboard Company vessel.

- Gross tonnage 1,100
- Length overall 46.2 m
- Breadth mid 14.5 m
- Aft deck space 185 m<sup>2</sup>

ROV system shall be fully operational for deployment on the filed by Q3 2022

- d) Company HSE Management System Manual compliant with international standards (e.g. ISO 14001, OHSAS 18001/ISO 45001) and / or list of HSE documentation applicable to the SoW activities;
- e) Evidence of Company Quality Assurance (QA) system;
- f) Company compliance with the Mozambican Laws and Regulation for the execution of the works.

## **II. Administrative Documentation**

- a) Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification and other relevant information from Eni Rovuma Basin B.V.;
- b) Last three years of Financial Statements and Annual Reports including Balance Sheet, Profit and Loss and Cash Flow Statement proving minimum financial capability to carry out the scope.
