

#### **EXPRESSION OF INTEREST**

#### FOR PROVISION OF PRODUCTION CHEMICALS AND RELATED SUPPORT SERVICES

**Eni Rovuma Basin B.V., Mozambique Branch** invites interested companies to submit their **Expression of Interest** for the PRODUCTION CHEMICALS AND RELATED SUPPORT SERVICES to support offshore Oil and Gas operations in Mozambique.

### **SCOPE OF WORK**

The scope of work consists of provision of PRODUCTION CHEMICALS AND RELATED SUPPORT SERVICES in Mozambique, in compliance with the relevant Mozambique legislation and maintain an internationally acceptable standard, as better detailed:

- Formulation and selection of chemicals for oil and gas production
- Supply of the full range of production chemicals (commodities and specialty) to the offshore production facility
- Logistics: chemicals transportation to Mozambique and storage in Mozambique
- Delivery of chemicals to point of embarkation in Pemba
- Chemical consumption monitoring and restocking
- Chemical performance monitoring, analysis and optimization
- Technical Consultancy services
- Laboratory analysis and field testing of chemicals
- Technical reporting
- Project Management and Reporting
- Management of wastes generated as a consequence of chemical supply scope activities (drums, chemical containers, laboratory equipment/reagents, etc.)
- Contractors' Warehouse and operative base shall be located in Pemba area at a distance not superior than 30 km from Company embarkation point in Pemba port (responsible for all permits and authorizations required to operate in compliance with local legislation, authorities and company policies).

The contractor shall provide any other facility/service and carry out any other activity directly or indirectly required for the provision of the services. These shall include, but not limited to:

- Mobilization and Demobilization of equipment and personnel
- Obtaining and managing Licenses and Permits
- Providing Certificates as required
- Accommodation/Transportation for Contractor personnel to the point of embarkation
- Provision and operation of chemical warehouse in accordance to Company Safety Standards

- Contractor telecommunications.
- Supply and management of appropriately skilled and experienced personnel
- Head Office Support.
- All Equipment required for the provision of requested services

Contract Duration will include a mobilization period, estimated to be maximum of one (1) year, plus three (3) years of full product and service provision starting from First Gas Production expected by 2022, for an initial estimated duration of four (4) firm years' period.

During mobilization period, Contractor shall set up the logistic infrastructure and be already operative in order to supply required chemicals and services for Commissioning and First Gas if required.

## **DOCUMENTS REQUIRED**

Companies interested to participate in this *Expression of Interest*, may submit the following mandatory information and documentation:

### I. Technical Documents:

- a) Contractor's HSE Management System Manual or list of documents evidencing alignment with international standards and evidence of certification;
- b) Required Certifications: ISO 9001, ISO 14001, OHSAS 18001/ ISO 45001 (required);
- c) Evidence of minimum 5 years' experience oil and gas field production and process chemicals and the associated technical and support services;
- d) Evidence of minimum 3 years' experience in Deepwater Subsea Applications for the provision of oil and gas field production and process chemicals and the associated technical and support services;
- e) Evidence of minimum 3 years' experience in Africa for the provision of similar services;
- f) Evidence of experience in supply/transfer of bulk chemicals to offshore oil and gas facilities via bunkering operations (ship to ship);
- g) Evidence of experience in formulating and blending chemicals for oil and gas production processes;
- h) Evidence of experience in compatibility assessment of chemicals with respect to materials, processes and other chemicals.

## **II.** Administrative Documents:

a) Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification package and other relevant information from the Eni Rovuma Basin B.V.;

- b) Last three years Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company Group (if applicable), and also for the Company's Mozambican registered entity that will enter into the subject contract;
- c) Company's registration in Mozambique. In case your Company is not already registered in Mozambique, please specify if you would be willing to promptly register in Mozambique and specify the respective timeline;
- d) Company and Group Structure with the list of major Shareholders and ultimate beneficiaries (if not listed in the stock exchange);
- e) In case you wish to participate in the *Expression of Interest* as a consortium or as a joint venture, information about each member of consortium or joint venture and role of each participant in the potential project. Such intention to form either a consortium or a JV, must be supported by an Agreement or "Memorandum of Understanding" duly signed by each entity in the group.
