FOR FIXED WINGS TRANSPORTATION SERVICES IN MOZAMBIQUE

Eni Rovuma Basin B.V., Mozambique Branch, invites interested companies to submit their *Expression of Interest* for the provision of **FIXED WINGS TRANSPORTATION SERVICES IN MOZAMBIQUE**.

SCOPE OF WORK

The scope of work consists of provision of passengers Air Transportation Services by means of one (1) twin-jet engines airplane, as detailed below:

- Commercial transportation of passengers and/or internal cargo of the Company, its Customers, its Agents, Contractors and Assignees from/to Main Operating Base, to/from Pemba, Maputo, Nacala and Nampula; neighboring Countries are also included within possible destinations
- Area of Operations is from/to Maputo to/from Pemba, Nacala and Nampula. Flights to/from neighboring Countries are also part of the scope of work.

Service shall be provided by means of one (1) twin-jet engines airplane during the Contract period, available within 24 (twenty-four) hours and ready to take-off within the following 6 (six) hours.

Operating Main Base is Maputo International Airport (MPM - FQMA).

The airplanes shall comply with the following characteristics:

- Twin-jet engines airplane;
- Passenger seating configuration approved for a minimum of 18 seats plus 2 Pilots Crew;
- Certification basis:
 - 1) FAR/EASA CS 25 or CS 23, dual engines
 - 2) Performance Class A, IFR Certificated, ILS Cat 1
 - 3) Two pilots crew with dual pilots' commands and cockpit

DOCUMENTATION REQUIRED

Such intention to form either a consortium or a JV, must be supported by an Agreement or "Memorandum of Understanding" duly signed by each entity in the group.

I. Technical minimum requirements:

- a) A valid Air Operator Certificate, including operations approval for the type of services required, available at the moment of submission of the expression of interest;
- b) Evidence of the Continuing Airworthiness and Maintenance Organization Approvals for the offered aircrafts;
- c) Evidence of the Air Operator having in place and maintaining:
 - A Compliance monitoring / Quality System applied uniformly throughout the entire operation (to include flight operations and maintenance), to monitor compliance with, and the adequacy of, procedures required to ensure safe operational practices and continuing aircraft airworthiness;

All activities shall have minimum impact on the environment and maximum care of health and safety of all parties, directly or indirectly involved in the activity.

During the tender phase, bidder shall submit a written declaration stating that will comply with ERB HSE Requirements.

- An Aviation-oriented Safety Management System using a proactive and reactive management of safety, which shall interface with the Quality System.

Both systems shall be documented to ensure traceability, standardization and communication.

- d) Safety Management System (OHSAS 18000 or ISO 45001) and Environmental Management System (ISO 14001) documents proving the company compliance with international standards;
- e) Quality Management System certifications and/or certificates proving compliance with international Quality Standards (ISO 9001:2008/2015);
- f) Company's HSE performance including events and incidents in the last three years. Total Recordable Incidents Rate (TRIR) shall be provided.

II. Administrative documents:

- a) Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification package and other relevant information from Eni Rovuma Basin B.V.;
- b) Last three years Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company Group (if applicable), and for the Company's Mozambican registered entity that will enter the subject contract;
