AEROMEDICAL EVACUATION

Medi Response will provide coordinated medical evacuation and repatriation services on behalf of its clients. Medical evacuation and repatriation can be requested at any times globally.

Medical evacuation and repatriation services consist of:


- 24/7 Global Command Centre
- Incident Support and Coordination Team
- Point of Incident to Home Transport Coordination
- Medical and Non-Medical Transport
- Air Transport Coordination and Ticketing
- Companion Ticketing
- Specialist Medical Equipment
- Pharmaceutical Requirements
- Other related logistical requirements
- Port Health Permits
- Stakeholder Communication and Notification Protocols



AEROMEDICAL EVACUATION PROCESS

The below outlines the evacuation process:

- Whilst making an evaluation on a medical evacuation, Medi Response's medical personnel monitor and evaluate the patient's medical condition and request the relevant authorizations to treat and transport the patient.
- Every Client is required to designate one to three Authorized Persons (AP) who are available 24x7 to approve the activation.
- Based on the patient's medical condition, it will be determined whether the patient is deemed "fit to fly" (i.e. air ambulance, commercial carrier with medical escort or Illegible to fly).
- Medi Response coordinates the logistics of ground transportation, exit and entry Port Health Permits, as well as ensuring all receiving facilities and logistic ground support are secured in advance.
- Medi Response ensures constant and direct communication to the AP, from activation to point of destination.
